THE REGISTRATION OF BIRTHS AND DEATHS (AMENDMENT) RULES,
2023

1. These Rules may be cited as the Registration of Births and Deaths (Amendment) Rules, 2023 and shall be read as one with the Registration of Births and Deaths Rules, 1922, hereinafter referred to as the “principal Rules”.

Commencement

2. These Rules shall come into operation on the 1st July, 2023.

Amendment of
rule 6

3. The principal Rules are amended in rule 6 by deleting subrule (1) and substituting for it the following:

“(1) For the registration of the birth of any child, where such birth occurs in any area prior to the date of the extension of compulsory registration to such area by order under section 27-

<i>Birth</i>	
(a)	Registration of the birth of any child for any period up to 3 months..... Free;
(b)	Registration of birth of any child for any period in excess of 3 months up to 10 years....8,000/=;
(c)	Registration of birth of any child for any period in excess of 10 years.....20,000/=;
(d)	Registration of the death of any person for any period within 30 days.....7,000/=;
(e)	Registration of the death of any person for excess of 1-month up to 10 years.....8,000/=;
(f)	Registration of the death of any person in excess of 10 years..... 20,000/=;

(g)	For alteration in the name and/or particulars of any child whose birth has been previously registered.....13,000/=;
(h)	For alteration in the name and/or particulars of deceased whose death has been previously registered.....13,000/=;
(i)	Certification of Birth Certificates for individuals/institutions/organization.....6,000/=
(j)	Search Fee.....3,000/=;
(k)	For certificate copy of any entry in the Registrar General Certificate.....7,000/=;
(l)	For Registration of Foreign Deaths.....30,000/=;
(m))	Adoption Certificate.....100,000/=.”
